Ms Connelly is an executive director of Scottish Power Energy Networks Holdings Limited ("SPENHL"), as well as an executive director on the Boards of the licensed holding companies and wholly owned subsidiaries of SPENHL (SP Transmission plc, SP Distribution plc and SP Manweb plc); as well as certain of SPENHL's other wholly owned subsidiary (SP Power Systems Limited).

Ms Connelly, as CEO of SP Energy Networks, leads a business with responsibility for getting the electricity from power generators to all 3.5 million customers in Central and South Scotland, Merseyside, and North Wales. As CEO, Ms Connelly is responsible for leading the business through the crucial RIIO-T2 and ED2 price control periods, improving the service we provide to our customers and stakeholders, maintaining a safe, secure and resilient network, and driving the transformation needed to ensure that SP Energy Networks plays a fundamental role in delivering Net Zero.
