1. Plug-in vehicle grant

The plug-in vehicle grant is a Government administered scheme that aims to reduce the initial purchase cost of brand new plug-in vehicles, making them more accessible. The grant value is automatically deducted from the retail price when an eligible new vehicle is purchased from an authorised dealership. The up-to-date list of all eligible vehicles can be found <u>here</u>.

The plug-in vehicle grant covers up to:

- 35% of the cost of a small van up to a maximum of £2,500. The van must have a gross vehicle weight of less than 2,500 kg, CO2 emissions of less than 50g/km, and an electric range of 96km (60 miles) or more.
- 35% of the cost of a large van up to a maximum of £5,000. The van must have a gross vehicle weight between 2,500 kg and 4,250kg, CO2 emissions of less than 50g/km, and an electric range of 96km (60 miles) or more.
- 35% of the cost of a motorcycle, up to a maximum of £500. The motorcycle must have a recommended retail price (RRP) of less than £10,000 (including VAT and delivery fees), no CO2 emissions, and an electric range of 50km (31 miles) or more.
- 35% of the cost of a moped, up to a maximum of £150. The moped must have a recommended retail price (RRP) of less than £10,000 (including VAT and delivery fees), no CO2 emissions, and an electric range of 30km (19 miles) or more.

In addition to the above, you may be able to get a grant towards the cost of converting a passenger vehicle into a wheelchair accessible vehicle. The grant would cover 35% of the vehicle cost, up to a maximum of £2,500. The vehicle must have a recommended retail price (RRP) of less than £35,000 (including VAT and delivery fees but not including the cost of conversion), no CO2 emissions, and an electric range of 112km (70 miles) or more.

2. EV chargepoint grant

The EV chargepoint grant is a Government administered scheme that aims to reduce the purchase and installation cost of domestic EV chargepoints. The grant provides a 75% contribution to the purchase and installation cost of one chargepoint, up to a maximum of £350 (including VAT). Under this scheme, the chosen installer of the chargepoint applies for the grant on your behalf and the grant value is deducted from the final quote provided by the installer.

The scheme is only available to:

- Homeowners who live in flats.
- Those living in rental accommodations (flats and single-use properties).



In addition to the above, to be eligible for the scheme, the following must be true:

- You own, lease, or have ordered an EVHS eligible vehicle.
- You have dedicated off-street parking at their property.
- The installer is **EVHS** approved and they install an **EVHS** approved chargepoint.
